4.	Items of Report	
	a. NHS Transition: SHA Clustering and LETB's	
	South East Coast SHA & LETB – GF informed members their proposed LETB is currently chaired by Medway's Chief Executive.	
	LETB has established Professional Advisory Group which meet intermittently and GF is a member of the group. GF stated that the introduction of LETB has not been a challenge for South East Coast.	
	South Central currently has 1 proposed LETB which has 2 councils. The 2 councils may possibly merge within the future.	
	East of England – ZA informed members that East of England have only been provided a limited amount of information regarding changes to SHA and introduction of LETB, but they have been reassured they can begin to plan for following academic year 2012/2013.	
	SS confirmed there are likely to be 3 LETBs to cover the Midlands and East of England but was unsure how this would work as a pharmacy workforce.	
	London – 3 LETBs will be introduced for London by April to cover North West, North Central East and South London. The role of the London Deanery in the new arrangements is unclear.	

b. Funding Models: Commissioned programmes and HEFCE funding changes

JS clarified there had been no further movement regarding HEFCE funding for postgraduate programmes.

Members from South East Coast met with SHA to discuss funding in December 2011 and the outcome of the meeting was positive. The hope is that any increase in fees would be gradual.

East of England confirmed they do not receive any HEFCE funding and their income was based upon commissioned basis. SHA funding needed to be confirmed.

London – UCL intend that the diploma should continue, with possible collaboration with King's.

It was noted that commissioning would continue to be sought in relation to the UCL diploma.

JS suggested consistency of programme fees would be of benefit, but, due to enrolment numbers, this may not be possible.

c. Collaborative working: Review of MoU

DW(c) clarified JPB programmes need to work within the geography to which they relate.

UEA – Confirmed they deliver the 1<sup>st</sup> 60 credits of the programme is taught same way as other partners but UEA do not offer DAPs. DW clarified UEA did not wish to leave JPB collaboration.

DW presented results of an informed Diploma survey. Practitioners from London, South East Coast and East of England indicated lower 'enjoyment' but also a higher proportion of 'not wanting to study after pre-reg'. They responded positively to 'Did you find the postgraduate programme helpful?'

DW suggested that UEA were likely to make some changes to their programme to their programme and agreed to share proposal with the Committee.

DW stated the JPB should be providing a development, with employers ensuring their practitioners are competent in the work place.

DW to provide outline of proposed changes to UEA Diploma.

All JPB members to provide short paragraph outline the academic role, employer role and how we communicate student progress onto Trusts.
